Impact Aid is a federal educational program that reimburses school districts for the loss of revenue associated with the presence of non-taxable federal property. For example, federal low-rent housing, national parks, federal buildings, Indian Trust or Treaty lands.

Impact Aid provides revenue that a community would otherwise generate through property, income, and sales taxes. It supports the school district's operating fund and is used to support all students in the district, just like other local tax revenue.

REVENUES FROM LOCAL, STATE AND FEDERAL SOURCES

Federal Impact Funds (Indian)

- A. The district will disseminate relevant applications, evaluations, program plans, and information related to the district's education program and activities with sufficient advance notice to allow tribes and parents of Indian children the opportunity to review and make recommendations.
 - 1. The completed applications, evaluations, and program planning will be handed out to parents of Indian children and Tribal officials during our regularly scheduled Indian Education Parent Committee meetings and during Tribal Consultations. A summary will be prepared and disseminated a minimum of 5 days in advance of public hearings held in December to afford all interested parties the opportunity to review the documents with sufficient time to provide thoughtful input at the public meetings. These hearings will be publicly advertised through flyers sent home to parents and on the district's website and social media platforms to allow all interested parties to attend. In addition, minutes from the Indian Education meetings will be posted on the District's website for all patrons and Tribal officials to review. This will allow for ongoing dissemination of information.

The district will provide an opportunity for tribes and parents of Indian children to provide their views on the district's educational program and activities, including recommendations on the needs of their children and on how the district may help those children realize the benefits of the district's education programs and activities. As a part of this requirement, the district will:


- Notify tribes and parents of Indian children of the opportunity to submit comments and recommendations, considering the tribe's preference for method of communication, and
- Modify the method of a time for soliciting Indian views, if necessary, to ensure the maximum participation of tribes and parents of Indian children.

JOM



The Johnson-O'Malley Act of 1934 was passed on April 16, 1934, to subsidize education, medical attention, and other services provided by States or territories to Indians living within their borders. Today, the Johnson-O'Malley program's purpose is to financially assist those efforts designed to meet the specialized and unique educational needs of eligible Indian students.

JOM funds are supplementary and are not intended to take the place of Federal, state, or local funds.

JOM

The JOM program is the only federally-funded educational program that allows for student, parent, and community involvement in meeting their educational needs which are both academic and cultural based.

- Students from age 3 through 12th grade are eligible for JOM if they are ¼ or more degree Indian blood or a member of a federally recognized tribe.
- The Omak School District currently has 222 JOM students.
- We welcome and encourage participation from families and community members at our Indian Education Committee Meetings.

Current Goals

$Title\ VI$



- Students are eligible to receive Title VI services if they are enrolled in a state or federally recognized tribe or are a first or second descendant, meaning at least one of their parents or grandparents is enrolled in a state or federally recognized tribe.
- The Omak School District currently serves 405 Title VI students.
- The district is required to submit an application every year in order to receive funds.
- The Title VI parent committee works with the district to develop the Title VI application.

Title VI

Title VI funds are intended to assist schools in meeting the unique cultural, language, and educational needs of American Indian and Alaska Native students to ensure that all students meet the challenging state academic standards.



- Facilitating hands-on learning









Evaluations & Program Planning


Graduation

Attendance


